10.30 - 12.00 Session I: Combating terrorism with the tools of International Law. Does the current international legal framework address all challenges that terrorism currently presents to the international community?

The second part will present the rationale behind the proposal to place the crime of terrorism under the jurisdiction of an international court. Why an international jurisdiction on Terrorism? Or, in other words, what added value would bring an International Court against Terrorism (ICT), as a new international jurisdiction? What would be the benefits of creating such a court? Why is the ICT necessary when, in practice, most States which have been the target of terrorist attacks preferred to submit the perpetrators of such acts to their own jurisdiction? What would be the advantages and drawbacks of placing terrorism under the jurisdiction of a new international court, different than the International Criminal Court (ICC)?

The third part will examine the challenges that must be addressed in the context of this project. How should the absence of a general accepted definition of the crime of terrorism be dealt with? Is it possible to overcome this obstacle, by taking into account the relevant jurisprudence, including the case-law of the Special Court for Lebanon? Would it suffice in order for the Court to attain its purpose to rely only on the definitions already agreed upon in the Sectorial UN Conventions in force? What other jurisdictional challenges can be envisaged and should be addressed in the context of the creation of this international court? How would the principle of complementarity be applied in case of overlapping jurisdiction between the ICC and the ICT? How should be dealt with acts of terrorism related to situations of armed conflict, which are governed by International Humanitarian Law? How to reach the right balance between combating terrorism efficiently and providing the appropriate safeguards to ensure the full protection of human rights and the rule of law? How to respond to the specific needs of the victims of terrorism?
